AMAKURU RUSANGE

1. Urubanza ruvuga iki?

Ku ya 10 Mutarama 2023, Jacinto Gomez Ovando na Maria del Carmen Peralta Baeza (hamwe, "Abitwa Abarega"), mu izina ryabo ndetse n'abandi bakozi bavuga ko bari mu gace kabu, batanze ikirego kuri Mountaire, bavuga ko Umusozi wananiwe kubaha amasaha yose yakoraga kandi ko atabayaye umushahara w'amasaha y'ikirenga ukekwha kubahiriza amategeko agenga ubuziranenge bwa Leta ya Carolina. ("NCWHA"). Ababuranyi bavuga kandi ko kugabanyirizwa umushahara rimwe na rimwe byakorewe ibikoresho byo kurinda no kugura inkoko bitemewe.

Mountaire ahakana ibirego byitiriwe abarega bavuga ko yarenze FLSA cyangwa NCWHA, cyangwa yananiwe guhemba neza abakozi bayo amasaha yose yakoraga kandi isaba amasaha y'ikirenga, kandi akomeza guhakana ibirego byitiriwe abarega bavuga ko agomba kuryozwa abarega mu bihe byose. Tutiriwe twemera inshingano, Mountaire yemeye kubikemura

avuga ko yirinda izindi manza.

Urukiko ntirwigeze rwemeza ko hari umuburanyi muri uru rubanza. Ababuranyi ariko, basabye ko uru rubanza rwakemuka batiriwe bemera uburyozwacyaha cyangwa amakosa ayo ari yo yose, kandi Urukiko rwemeye kumenyesha icyo cyifuzo cyo gukemura abashobora kwemererwa kubigiramo uruhare.

2. "Igikorwa rusange" ni iki, "Igikorwa cyo mu rwego ni iki?", kandi ninde ubifitemo uruhare?

Muri FLSA, niba urukiko rwemeje ko urubanza rugomba gufatwa nk "igikorwa rusange," itsinda ryabantu "basa nkaho" rishobora gushaka kwishyurwa umushahara w'amasaha y'ikirenga utishyuwe hamwe n'indishyi zijiyanie nabyo. Mubikorwa rusange, abantu "bahitamo" murubanza batanga uburenganzira bwo kwinjira, bahinduka abarega. Rimwe na rimwe bakunze kwitwa "opt-in abarega." Abantu batangiza uru rubanza, bitwa "abarega," bazana ikirego mu izina ryabo bwite ndetse n'abandi bantu bakekwa ko bafite ibyo basaba kandi bashobora kwemera kwitabira iki gikorwa.

Ubu bwoko bwa "opt-in" ibikorwa rusange bitandukanye nibikorwa bizwi cyane "ibikorwa byamasomo," aho abitabiriye amahugurwa badakeneye gutanga uruhushya rwanditse rwo kwinjiramo. Mu gikorwa cy'ishuri, "abitwa abarega" barega mu izina ryabantu bose bari mu itsinda ryasobanuwe cyangwa "itsinda." Niba urukiko rwemeje ko urubanza rugomba gufatwa nk "igikorwa cyo mu rwego rwo hejuru," abantu bose bari mu itsinda ryasobanuwe bahita bahinduka "abanyamuryango" keretse batanze ikirego mu rukiko basaba ko cyakurwaho. Mu nkiko za federasiyo, ubu bwoko bwimanza bwitwa "Ingingo ya 23" ibikorwa byiciro.

Abitwa abarega hano - Jacinto Gomez Ovando na Maria del Carmen Peralta Baeza - batanze uru rubanza nk'ikirego rusange hamwe na FLSA ndetse n'igikorwa cyo mu rwego rwo hejuru hakurikijwe amategeko ya leta ya Carolina y'Amajyaruguru. Igikorwa rusange giteganijwe muri FLSA kizaba kirimo abakozi bose batunganyirizwa inkoko basonewe bakorehwa na Mountaire muri kimwe mu bigo byayo bitunganya inkoko muri Carolina y'Amajyaruguru igihe icyo ari cyo cyose hagati yitariki ya 10 Mutarama 2020 na 20 Ukuboza 2024 kandi bahitamo uru rubanza batanga uruhushya rwanditse mu Rukiko. Byongeye kandi, abarega bashatse kurega mu rwego rw'amategeko ya leta ya Carolina y'Amajyaruguru mu izina ry'icyiciro cy'abakozi bose batunganyirizwa inkoko basonewe na Mountaire muri kimwe mu bigo byacyo bitunganya inkoko muri Carolina y'Amajyaruguru igihe icyo ari cyo cyose hagati ya 10 Mutarama 2020 na 20 Ukuboza 2024.

Muri ubwo bwoko bwombi bw'imanza, abarega barashobora gusaba urukiko kwemeza urwo rubanza nk'urwego cyangwa / cyangwa ibikorwa rusange.

Niba urukiko rwemeye icyo cyifuzo, urukiko rumwe rukemura ibibazo biri murubanza kubantu bose bashobora guhitamo abarega hamwe nabanyeshuri. Urukiko rw'intara rwo muri Amerika mu karere k'iburasirazuba bwa Carolina y'Amajyaruguru ni urukiko rushinzwe iki gikorwa rusange hamwe n'ibikorwa byo mu rwego. Kugira ngo iki kibazo gikemuke, Urukiko rwemeje icyemezo cy'icyiciro cy'Abarega hamwe

n'ibikorwa rusange kugira ngo bikemurwe gusa kandi byemerewe koherezwa ku banyamuryango bujuje ibisabwa / ibyiciro mbere yuko Urukiko rufata icyemezo cyo gutanga icyemezo cya nyuma cy'imiturire.

INYUNGU ZO GUKEKURA - ICYO URABONA NICYO UTANGA

5. Ni izihe nyungu n'amabwiriza yo gutuza?

Ababuranyi bemeranijweho amafaranga angana na \$ 7.260.000 ("Amafaranga yo kwishyurwa yose") akubiyemo umushahara wose uvugwa ko utishyuwe, igihe cyagenwe, indishyi z'amasha y'ikirenga, indishyi zaseswa, inyungu, igihembo cya avoka w'abavoka bo mu cyiciro, amafaranga n'amafaranga yakoreshejwe, Ibihembo bya serivisi ku barega amazina, amafaranga yo gucunga no gukemura ibibazo byose.

Hazaba iburanisha ryemeza burundi gutuzwa ("Iburanisha ryanyuma"). Niba Urukiko rwemeje gukemura, kandi uga tanga urupapuro rwabigenewe kandi mugihe gikwiye, uzahabwa ubwishiyo. Niba wakiriye ubwishiyo bwo kwishyura, uzaba ushinzwe kwishyura imisoro yose winjiza ugomba kwishyura.

Nyuma yigihembo cyemejwe na avoka, ikiguzi nibisohoka, ibihembo byose bya serivisi byemewe kubarega bitwa abarega, hamwe namafaranga yubuyobozi bwo kwishura yishyurwa bivuye kumafaranga yatanzwe, amafaranga asigaye ("Net Settlement Amafaranga") azahabwa abanyamuryango bose bujuje ibyangombwa hamwe n'amafaranga buri mutu ku giti cye afite uburenganzira bwo guhabwa hashingiwe ku isesengura ry'abavoka bo mu cyiciro cya Leta. 8. Amafaranga y'abavoka, ikiguzi, n'amafarangaakoreshwa birashakishwa?

12. Nategereza kwakira angahe?
